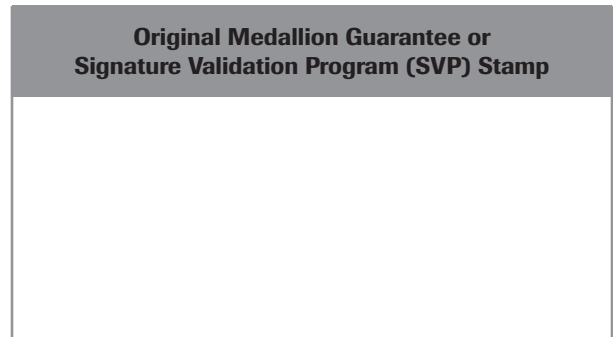

A Medallion guarantee is designed to protect the account from fraud and may be obtained from any of the following institutions participating in one of the Medallion guarantee programs:

- bank or trust company;
- savings association;
- credit union; or
- broker, dealer, or securities exchange member.



Signature Verification by a notary public is not an acceptable substitute. The signature Validation Program Stamp may be used for non-financial transactions.
